## Foreword

This translation has been made based on the original Japanese Industrial Standard revised by the Minister of Economy, Trade and Industry through deliberations at the Japanese Industrial Standards Committee as the result of proposal for revision of Japanese Industrial Standard submitted by Japan PVC Pipe and Fittings Association (JPPFA)/The Japan Plastics Industry Federation (JPIF)/Japanese Standards Association (JSA) with the draft being attached, based on the provision of Article 12 Clause 1 of the Industrial Standardization Law applicable to the case of revision by the provision of Article 14. Consequently **JIS K 6776:2007** is replaced with this Standard.

However, **JIS K 6776:2007** may be applied in the **JIS** mark certification based on the relevant provisions of Article 19 Clause 1, etc. of the Industrial Standardization Law until October 19, 2017.

# Chlorinated poly(vinyl chloride) (PVC-C) pipes for hot and cold water supply

## Introduction

This Japanese Industrial Standard has been prepared based on the second editions of **ISO 15877-1** and **ISO 15877-2** published in 2009 with some modifications of the technical contents including addition of requirements concerning product dimensions, performance and their test methods that are widely used in Japan.

Sidelines or dotted underlines indicate changes from the corresponding International Standards. A list of modifications with explanations is given in Annex JB.

## 1 Scope

This Standard specifies chlorinated poly(vinyl chloride) (PVC-C) pipes (hereafter referred to as pipes) intended to be used for piping systems for conveyance of hot and cold water at 90 °C or lower.

**NOTE :** The International Standards corresponding to this Standard and the symbol of degree of correspondence between **JIS** and the International Standards are as follows.

ISO 15877-1:2009 *Plastics piping systems for hot and cold water installations—Chlorinated poly(vinyl chloride) (PVC-C)—Part 1: General*

ISO 15877-2:2009 *Plastics piping systems for hot and cold water installations—Chlorinated poly(vinyl chloride) (PVC-C)—Part 2: Pipes* (overall evaluation: MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standards and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
