Consequently **JIS B 1111:2006** is replaced with this Standard.

However, **JIS B 1111:2006** may be applied in the **JIS** mark certification based on the relevant provisions of Article 19 Clause 1, etc. of the Industrial Standardization Law until March 20, 2018.

# Cross recessed head screws

## Introduction

This Japanese Industrial Standard has been prepared based on the third editions of ISO 7045 and ISO 7047 published in 2011, and the second editions of ISO 7046-1, ISO 7046-2 and ISO 7048 published in 2011 by incorporating the parts corresponding to this Standard (shape and dimensions, product specifications and designation) without any modifications of the technical contents, but also adding some specification contents that are not given in the corresponding International Standards.

The dotted underlines indicate addition to the corresponding International Standard. A list of modifications with the explanations is given in Annex JB.

This Standard contains the following Annex, not given in the ISO Standards, for providing the requirements that correspond to manufacturing and usage of product in Japan.

Annex JA Cross recessed head screws not in accordance with ISO 7045 to ISO 7048

## 1 Scope

This Standard specifies the characteristics of cross recessed head screws.

If, in special cases, specifications other than those given in this Standard are required, they can be selected from existing Japanese Industrial Standards, for example JIS B 0205-2, JIS B 0209-3, JIS B 1009, JIS B 1051 and JIS B 1054-1.

Further, the cross recessed screws not in accordance with ISO 7045 to ISO 7048 are given in Annex JA.

NOTE : The International Standards corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 7045 : 2011 *Pan head screws with type H or type Z cross recess — Product grade A*

ISO 7046-1 : 2011 *Countersunk flat head screws (common head style) with type H or type Z cross recess — Product grade A — Part 1 : Steel screws of property class 4.8*

ISO 7046-2 : 2011 *Countersunk flat head screws (common head style) with type H or type Z cross recess — Product grade A — Part 2 : Steel screws of property class 8.8, stainless steel screws and non-ferrous metal screws*

ISO 7047 : 2011 *Raised countersunk head screws (common head style) with type H or type Z cross recess — Product grade A*

ISO 7048 : 2011 *Cross-recessed cheese head screws (Overall evaluation: MOD)*
