Introduction

This Japanese Industrial Standard has been prepared based on the fifth edition of ISO 132 published in 2011 with some modifications of the technical contents.

The vertical lines on both sides and dotted underlines indicate changes from the corresponding International Standard. A list of modifications with the explanations is given in Annex JB.

1 Scope

This Standard specifies a method of test intended for use in comparing the resistance of vulcanized or thermoplastic rubbers to the formation and growth of cracks, when subjected to repeated flexing on the De Mattia type machine.

NOTE : The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 132 : 2011 *Rubber, vulcanized or thermoplastic — Determination of flex cracking and crack growth (De Mattia)* (MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standard and JIS are IDT (identical), MOD (modified), and NEQ (not equivalent) according to ISO/IEC Guide 21-1.
